Section 4. First aid measures

Description of necessary first aid measures

- Appropriate engineering controls** : Good general ventilation should be sufficient to control worker exposure to airborne contaminants.
- Environmental exposure controls** : Emissions from ventilation or work process equipment should be checked to ensure they comply with the requirements of environmental protection legislation. Conclusion/Summary : **Distillates (petroleum), hydrotreated heavy paraffinic**: Mineral oil mists derived from highly refined oils are reported to have low acute and sub-acute toxicities in animals. Effects from single and short-term repeated exposures to high concentrations of mineral oil mists well above applicable workplace exposure levels include lung inflammatory reaction, lipoid granuloma formation and lipoid pneumonia. In acute and sub-acute studies involving exposures to lower concentrations of mineral oil mists at or near current work place exposure levels produced no significant toxicological effects.

Distillates (petroleum), solvent-dewaxed heavy paraffinic: Mineral oil mists derived from highly refined oils are reported to have low acute and sub-acute toxicities in animals. A life-time dermal application of severely hydrotreated light naphthenic oils produced skin masses on mice which correlated with the skin irritation response levels of the test animals. These materials have not been determined to be carcinogenic by IARC, NTP or OSHA.
